In view of the shortage of Specialist Cardiology Doctors in the various hospitals in the State and considering the fact that the Medical Colleges have been made fully referral hospitals and these doctors have experience in cardiology, it is now decided to engage the services of Doctors who hold the PGDCC in the hospitals in the State having ICU Facility. 

Most these doctors have working experience in different tertiary hospitals in Cardiology department.
