This is to the reference of letter F.No Z-28101/60/2021-MNE dated 1st December 2021 regarding the Examination of the issue of Recognition of Post Graduate Diploma in Clinical Cardiology (PGDCC) qualification awarded by IGNOU during 2006-2013. Please find the information as desired in the given below:

1. Whether any communication was done with MOHFW/NMC or necessary approval taken from MOHFW regarding starting of course. If so, the details thereof and endorsement of documents like office order, documentation & Minutes of Meeting etc. pertaining to the same.

Answer: No Prior approval was taken from MCI. However, the then Health minister Sri (Dr.) Ambumani Ramados had inaugurated the launching of the programme through a televised ceremony held on 20th December, 2005. (Annexure 1A)

- 2. Whether any MoU was made with the Institution/Hospitals which were designated as Programme Study Centre by IGNOU. If so, the copies of the same may be submitted. Answer: Yes. MoU was made with each Institution/Hospitals which were designated as Programme Study Centre by IGNOU for the PGDCC programme. (Annexure 1) [Programme Guide: Page No 62-70 (Blank Format)]
- 3. Was any prior inspection conducted by IGNOU or MCI to verify the credentials of the Institutes/Hospitals before enrolling them as ProgrammeSutdyCentes.

 Answer: Yes. Prior inspection is an essential step for IGNOU before signing MOU with any programme Study Centre (PSC). The same was followed before establishment of each PSC. (Annexure 1)
- 4. Did the institutions where the course was conducted had any agreement with Medical colleges having pre/para clinical courses before they were inducted as Programme Study Centre.

Answer: The guidelines for selection of PSC mentioned that centre conducting DM/DNB in cardiology would be eligible for PSC. Where, ongoing cardiology programme was not there, other conditions were applied. (Annexure 2)

- 5. Whether IGNOU had fixed any Minimum Standard of Requirement similar to Section 8 of PGMER 2000 Regulations which have to be maintained by Institute in terms of Infrastructure, faculty and clinical materials before starting a medical course. Was any inspection conducted at Institutes w.r.t Minimum Standard Requirements before inducting them as Programme Study Centres.
 - Answer: Yes. The checklist is attached. Number of students for admission to a PSC was restricted to the availability of number of cardiologist having of DM/DNB in cardiology/Mch in cardiothoracic and vascular surgery. The ratio was maintained at 1:2. (Annexure 2) [Programme Guide: Page No 62-70]
- 6. Submit course curriculum and log book details devised for the course including number of lectures/clinical lectures and practical required for successful completion of the course.

 Answer: Copy of curriculum and six logbooks designed for the purpose are attached.

Answer: Experts with DM/DNB (Cardiology) were the eligible to be teacher/faculty of PGDCC programme. Qualification of all counselors attached. One year teaching schedule of one institution for 2014 is attached. (Annexure 2) [Programme Guide: Page No 62]

- 8. How many of 1700 students enrolled for the PGDCC course between 2006 and 2013 had done MD (Medicine), or MD (Padeiatrics) or MD (Respiratory Medicine) which are the requisite feeder courses for MD (Cardiology).

 Answer: An Eligibility criterion of the admission to PGDCC was MBBS. Data regarding additional higher qualification was not recorded and hence it is not available in the Students Registration Division (SRD) of IGNOU.
- 9. Criteria of Entry and Exit Examination for the Course. Whether any Entrance Exam was held for admission to course with details. What were the rules of exit exam take for completion of course. Whether examination was conducted by Internal or external Examination. Whether the practical was conducted at the same Institute where the candidate studied of different institute.

Answer:

- MBBS degree was required to enrolled in PGDCC programme.
- Entry in PGDCC was done by entrance examination which was held once a year at national level following GOI reservation policy.
- Course-wise seven theory internal examination was conducted by the Programme Study Centre. Answer scripts were examined by the Programme Study Centre.
- Course wise theory examination of Term End Theory Examination was conducted by the University. Answer scripts were examined by the University with central pool of examiners.
- The Internal examination of 6 practical courses was conducted course-wise by the Programme Study Centre with internal examiners.
- Term End Practical Examination was conducted by the University with internal and external examiners. Students Teacher Ratio of the term end practical examination is given below. (Annexure 3A)
- Students need to pass in each component (Internal and term end examination) separately. The suggested number of the Examiner and students are given below:

If they failed in the term end practical examination then they needed to produce the same log books in the next term end practical examination as per rules of the University. Six Log Books of a Student from Private Institute (National Heart Institute, New Delhi) could be collected and enclosed. However, it would not be collected from and Govt. Institute.
